Dear Tenant or Landowner:

The City of Omaha is happy to inform you that the 120<sup>th</sup> Street Project – Stonegate Drive to Roanoke Boulevard is moving into final design. Please be aware that project personnel will be working along the corridor in the near future to perform geotechnical soil borings, survey and wetland delineations.

Topographic Survey and Wetland Delineations

Please note that no interruption in traffic flow will result from this work.

During the field work, it is necessary for our crew(s) to obtain data from all properties along and abutting this corridor. This will require our crew(s) to enter your property adjacent to the roadway and collect survey data approximately 100 feet beyond your property line. Often, this means collecting survey data up to the corners of buildings.

Please advise if special arrangements will need to be made before entering your property.

Geotechnical Soil Borings

Truck-mounted drilling equipment will require temporary closure of one lane of traffic during collection of soil borings. Boring locations will include the vicinity of the West Maple Creek Bridge and the Big Papillion Creek Bridge. Shallow borings will also be taken between West Maple Road and Big Papillion Creek within 100 feet of the centerline of 120<sup>th</sup> Street. Traffic control will be done in accordance with City of Omaha traffic control and barricade standards.

The City will hold a preconstruction meeting for the 120<sup>th</sup> Street Project – Stonegate Drive to Roanoke Boulevard to provide the community a chance to see the final design and to provide information on the schedule of construction activities. We are anticipating this meeting to be held in late 2019 to early 2020 pending construction funding.

Your input throughout the preliminary design process played a significant role in developing the final design. The Open House Public Meeting Report is posted on the City's project website at the link provided below. This report enables you to see what your neighbors and other community members think about the improvement project and the design alternatives. Thank you for your continued interest and contributions to the project.
